BR	Bursar Reg (Past Due > \$1500)	<u>Bursar</u> (618-453-2221)	Bursar account is currently past due more than \$1500. Account now needs to be paid down to less than \$1500 in order to register for classes.
HS	Health Service Missing Shot Records	<u>Student Health</u> <u>Services</u> (618-453-4326)	Per Illinois law, proof of immunizations has not yet been completed. See <u>here</u> to do so.

SATISFACTORY ACADEMIC PROGRESS (SAP):

- In order to receive federal financial aid funds, students must meet 3 minimum requirements, including:
 - Pass Rate Rule Must successfully pass 67% of hours attempted (Ws and Fs are counted against this)
 - GPA Rule Maintain a minimum 2.0 GPA
 - Max Hours Rule Students must complete the degree program before reaching 150% of the number of credits needed to complete their degree program. (Most degrees require at least 120 earned credit hours).
